Direction: Travelling along Victoria Road in Diss from Tesco continue along this road past the turning to Stuston and on your left there is a turning before you reach the traffic lights, take this turning and the property can be found in the far right hand corner.

The Property: A modern property consisting of; kitchen leading into the dining area with patio doors out to the garden. The Dining room leads into the spacious living area.
