Direction: From Diss travelling on Shelfanger Road (B1077) follow this road through Shelfanger village, continue on this road until it brings you into Winfarthing, passed the pub the road forks, take the right hand turning onto Hall Road where the property can be found on your right hand side.


Tenancy Agreement: A draft copy of the tenancy agreement will be available for inspection at the Agent's offices.
